## Start Your Business Training Workshops (SYB)

Due to the importance of these workshops within livelihood program of Syrian refugees, DSPR conducted (4) SYB training workshops for (100) Syrian women at Talbiah, Souf, Irbid, and Amman (Hashmi) governorates. This year, these workshops witnessed more focus on what after the training workshops the graduates will do, how DSPR can support them in establishing their own businesses and how this can be connected to the Small Medium enterprises project supported by ICCO & KerkinActie.

DSPR/Jordan and, ICCO/KerkinActie (I&K) cooperate to structurally contribute to the strengthening of the Jordan SME eco-system with the goal to enhance livelihood for both the Jordan host community as well as Syrian/Iraqi refugees of different backgrounds, as a form of sustainable aid.

### Rationale

The project addresses the gap between the business potential of refugees and the lack of options to render this potential into business development, as well as the social divide between host and refugee communities. From an NGO perspective efforts are being taken to train refugees and hosts in (re-)starting up a business. Assets of loan and capital however are neither hardly available nor are business development services and technical assistance. These two elements are the backbone of the pilot project that DSPR Jordan and I&K undertake. After assigning Business Development Manager for this project, the following steps were taken into action progress of this project is highlighted below:

- 1- TOR for the project was prepared
- 2- Met with different Organizations
- 3- Prepared application forms in both Arabic and English
- 4- Launched a pilot project aiming to provide 5 entrepreneurs with loans without interest with a ticket size of 30,000 Euro per entrepreneur
- 5- Disseminated Applications for interested parties
- 6- Arranged translation of applications from Arabic to English
- 7- Loan agreement was prepared
- 8- Evaluation sheets were prepared (Admin check and technical assessment)
- 9- Started Evaluation

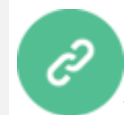
